# CHAMPIONSHIP RULES

1. Under 15 OPEN & GIRLS - Player born on or after 2009 are only eligible to participate.
2. Four players in each category from every affiliated District Association of CAK.
3. All other entries considered as Special entries should come through the concerned affiliated District Association of CAK. No direct entries will be entertained in any circumstances.
4. System of Play: Championship will be played as per latest FIDE Rules.
5. Default Time: Default time for arriving to the chess board is 15 minutes.
6. Time control: 40 Minutes + 5 Seconds increment
7. Tie- break: Buchholz Cut 1, Buchholz, Sonneborn Berger, Direct encounter, number of wins (including forfeit points)
8. Withdrawal: A player may withdraw at any stage of the event only after informing the Chief Arbiter in writing.
9. Players are not allowed to use any type of watch, mobile, or any such electronic device in the playing area.
10. Protest: If any against the decision of the chief Arbiter shall be made in writing with a Protest fee of Rs. 1000/- within 15 minutes of the occurrence of the incident.
11. The Protest fee will not be refunded if the appeal is rejected.
12. Eligibility for National Championship 2024 is only limited to concerned State Championship participants.
13. No spot entry allowed.
